4. FIRST AID MEASURES

First aid measures

General advice

If symptoms persist, call a physician.

Eye contact

If symptoms persist, call a physician. Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Rinse thoroughly with plenty of water for at least 15 minutes, lifting lower and upper eyelids. Consult a physician. Immediately flush with plenty of water. After initial flushing, remove any contact lenses and continue flushing for at least 15 minutes. Keep eye wide open while rinsing.

Skin Contact

If skin irritation persists, call a physician. Wash off immediately with plenty of water for at least 15 minutes. Immediate medical attention is not required. Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes.

Inhalation
